Retail Theft at Kohl's (200 block of West Chester Pike) on 3/5 @ 1855 hours – An unknown female stole an unknown amount of travel perfumes from the Sephora section of the store.

They asked for his cooperation during an investigation under threat of charges being filed against him for his “involvement”. The caller gave the legitimate name of an agent and spoofed the phone number. The victim believed it was an official call and completed the transactions that were requested. The total loss was approximately \$100,000.00.

Theft at Wynnewood Lanes (2200 block of Haverford Road) on 3/8 @ 2237 hours – The victim reported that his cell phone was stolen while he left it unattended on a table.
